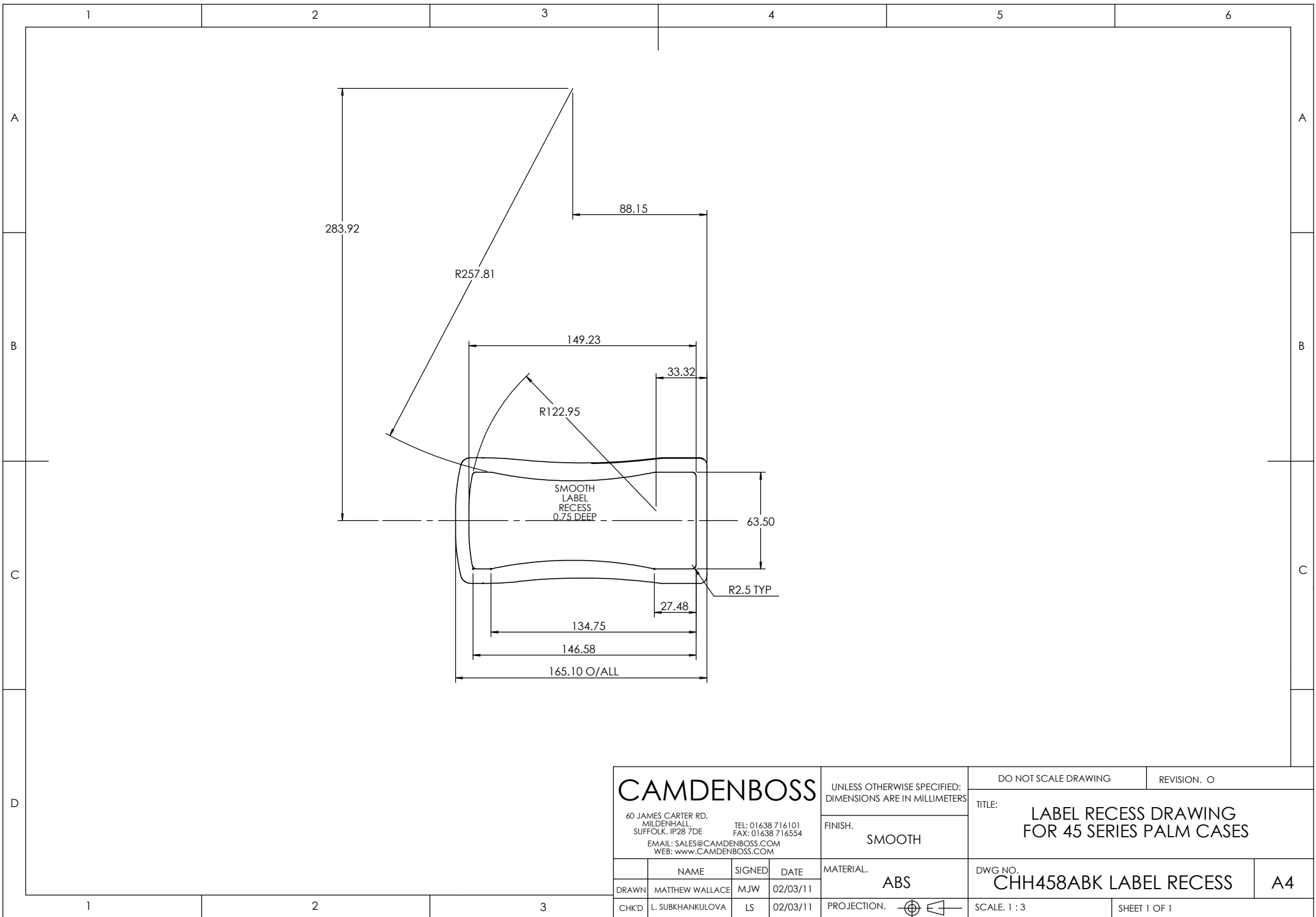


TOP PCB MOCK-UP
